Privacy policy for agriturismoatancanoa.com web site (art. 13 D.lgs. 196/03). In this page we describe the modalities for this site to manage personal data collected about the user, in order to respect the law - art 13 del D.lgs n° 196/2006 and the General Data Protection Regulation (GDPR) (EU) 2016/679.

Ownership of Personal Data Handling

Mr. Posadino Dino (via Case Sparse 2, 07030 Tergu SS -Italy) of the society Soc. Agricola Sa Tanca Noa has the ownership of personal data handling.

Place of Personal Data Handling

Data management connected to services of agriturismoatancanoa.com happens in the location of via Case Sparse 2, 07030 Tergu SS -Italy (and on the remote server of the site). None of the collected data is shared with other organizations or agencies. Personal data provided by users, sending requests for information through the contact section, are used to perform the requested service.

Type of Data Management

The site is almost entirely navigable without having to communicate any personal data.

Personal information, voluntarily shared by the user

Personal information (name, telephone number and e-mail address) are required only in the Contact section. This information are used for the required serviced; in particular for answering requests for information by the user, and manage request of availability or reservations.

Navigation data

The computer systems and the software of this website use, during their normal operation, personal data whose transmission is implied in the execution of Internet communication protocols. These information are not collected to be associated with an identified user, but for their kind they could allow to identify people, through elaborations and associations with data held by third parties. This category of data includes the IP addresses or domain names of the computers used by the users that connect to the site, the URI addresses of the required resources, access times and other technical parameters related to navigation, operating system and computer environment of the user. This data are used only for the purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing.

Data Holding Processing

Personal data are handled with automated tools for the time necessary to achieve the purposes for which they were collected, by providing the required information.

In any case, the retention period will not exceed the 10 year threshold.

Currently, the legislation requires companies to keep legal and commercial emails for 10 years on the basis of articles 2214 of the Civil Code and 22 of DPR 600/1973.
